INVITATION FOR EXPRESSIONS OF INTEREST

Hengyi Industries Sendirian Berhad (HYBN) invites interested companies to submit Expressions of Interest (EOI) for the following work:

PROVISION OF INTERNATIONAL LOGISTICS SERVICES (REF:MSD652915)

1. Tender brief of work

- The esteemed contractor will undertake the responsibility for comprehensive logistic services and tools necessary for the service, including transportation, packaging, etc. This encompasses:
 - Provision of International Shipping Services: Transportation of bulk-cargo and shipping containers, as well as delivery service for equipment, machinery, materials, and construction tools to Pulau Muara Besar (PMB), with an approximate capacity of 100 tons or 500m³ per trip.
 - Logistics Schemes: Deployment of professionals to develop and implement feasible logistics schemes, including loading supervision tailored to the diverse sizes and weights of cargo.
 - Document Preparation: Compilation of all requisite documents, such as container or bulk-cargo inquiry, booking, and in-land transportation services in major ports globally (e.g., Houston, USA; Liverpool, UK; Shanghai, and Tianjin, China). Additionally, the contractor will handle the submission of berth notes or packing lists to secure shipment bookings, cargo reception, and storage at the loading port.
 - Customs Clearance: Proficiency in import customs clearance and transportation policies across various countries. This entails overseeing cargo unloading at the destination port, implementing effective measures for logistical organization, and facilitating the transportation of cargo from the discharging port to warehouses, including application entry and custom clearance.
 - Land Transport Arrangements: Coordination of land transport, encompassing movement from port to PMB and within PMB itself, facilitating short-distance travel between various points (such as warehouse to site, etc), involving a fleet of 15-20 trucks, each capable of carrying 20 tons, or a minimum of 5 trucks with a capacity exceeding 30 tons, to accommodate cargo with a width exceeding 2.4 meters. Additionally, HYBN assumes responsibility for managing all permit applications required for entry into PMB, ensuring smooth and efficient logistics process.
 - Compliance: Adherence to Hengyi's policies and pertinent Brunei Darussalam and International Legislations throughout the logistics operations.
